Dear ASA Members

Please note that ASA is in process of ordering 2019 ASA Permanent and Temporary Licenses.

If all go well; licenses will be delivered in December 2018. A delivery schedule will be provided in due time.

Please find attached the 2019 ASA Permanent License form. The 2019 ASA Permanent License form is available in excel format on the ASA website <http://www.athletics.org.za/licences>.

ASA Members are advised to start with the ordering of numbers from club members as soon as possible, as no license can be issued to an athlete unless the attached application form is signed, and in the possession of the Club.

The ASA Permanent License must not be issued unless the Club Representative can present a signed application of the relevant athletes.

Provinces must ensure that members understand that an ASA License; be it a permanent or temporary license, has the same status as an ID document or passport.

Anybody whom obtain a license illegally, or duplicate the license in any way other than set out in ASA Rule 25 may be criminally prosecuted.

Provinces must also ensure that their members, in particular Event Organizers whom do not apply ASA Rule 26, may also be criminally prosecuted.

Members whom are in doubt with the application of ASA Rule 25 and 26 must obtain clarity from the Provincial Technical Committee. Only provinces, if in doubt can contact ASA att: Durell JeJane durellj@athleticssa.co.za.
